



Eligibility and Benefits

- 1) As per the Quebec Business Immigration Program, anyone who has a personal/combined (spouse) net worth of CAD 1.6 million (INR 9 cr) is eligible to obtain PR(White Card) in Canada. All dependent children and the applicant, along with spouse will be residents within 24 to 36 months of the application.
- 2) The applicant is required to have a minimum of 2 years of management experience within the past 5 years.
- 3) The net worth includes immovable properties such as house / flat, land including agricultural land, AND movable properties such as fixed deposits, bank deposits, good will of the business, LIC policies, stocks etc.
- 4) The applicant is not required to have knowledge of the English language and need not have a formal education. In this category, the applicant does not have to undergo any educational examinations.
- 5) Even if the applicant had been refused the American visas, he can still apply for this program and the success ratio is 99%.
- 6) The Applicant will be required to make the payment of the application fees directly to the Quebec Government and the Bank. Our consultation fee will be due, once the visas have been stamped*.
- 7) After getting your PR and residing in Canada for 4 years, you will be eligible to apply for Canadian citizenship. Once you are a citizen you can move freely to US, UK/Australia etc without visas.
- 8) You and your family will enjoy the benefit of free medical all your life once you obtain your PR.
- 9) Your children will study free until grade 12, and will be able to get an interest free loan from the government for further education (which is 25 % of the International fees) lodging and boarding upto CAD 18,000 per year.

*Conditions apply

PROCEDURE / FEES STRUCTURE:

- 1) Once all the documents are in order and ready to be submitted. The applicant will be required to pay the application fees amounting to CAD 15,000 via a draft in the name of the Quebec government.
- 2) Once the application is made, the acknowledgement will be received in 1-2 months.
- 3) There will be an interview scheduled in Montreal or Hong Kong within 10 to 12 months. Some times the interview is waived.
- 4) After the interview and/or receiving the invitation from the Quebec Government, the applicant is required to make a deposit of CAD 800,000(INR 4 Cr.) in a non interest-bearing bond with the government for a period of 5 years.

OR

We can make arrangement with a Canadian Bank, that they pay this deposit, and applicant only pays interest @ 5.5% per Year for 5 years totaling to CAD 2,20,000 (INR 1.10 cr Appox.)

- 5) Once the deposit is made, the applicant will be required to submit an application to Federal Government, with the proof of the deposit. The applicant will have to pay fees of CAD 1,050, spouse CAD 550 and CAD 150 for each dependent.
- 6) After which, with in 12-13 months they will be required to give their medicals and submit security clearance.
- 7) Once cleared the visas will be issued in 2 months.

Note:

The visas can be rejected based on the following 4 reasons:

- 1) The applicant, spouse or their children are medically unfit. (aids, cancer, T.B. etc)
- 2) The net worth is acquired as a result of smuggling, Arms or illegal activities.
- 3) There is a criminal record against any family member.
- 4) The documents produced before the embassy is forged.
